Wade H. Batson died testate August 6, 1935, per Apt. 336, File 5, devising same to Henry A. Batson for life, with remainder to his brothers, Wade T. Batson, Ben P. Batson and R. W. Batson, or if they died, to their children.

Wade T. Batson died intestate in Apt. 618, file 56, on January 25, 1953, leaving a widow, Lenora H. Batson, and two children, Wade Thomas Batson, Jr., and Helen Louise B. Bose. Lenora H. Batson died September 6, 1964, in Apt. 883, File 16, and by her Will devised to Wade T. Batson Jr., and Helen Louise B. Bose.

Benjamin Perry Batson died testate on February 9, 1941, in Apt. 437, File 6, devising his property to his wife Josephine Simmons Batson. Josephine died testate on July 29, 1944, in Apt. 480, File 29, devising to her daughter, Susan Pauline Batson.

R. W. Batson died testate October 3, 1949, in Apt. 577, File 29, devising unto his wife, Jennie (Jannie) Batson. Jannie died testate October 22, 1959, in Apt. 715, File 24, devising unto her five children: D. Grady Batson, B. Tom Batson, R. Leo Batson, Lila B. Freeman and Frank Batson. Lila B. Freeman died testate February 10, 1970, in Apt. 1117, File 17, devising unto her daughter Batsie F. Styles. R. Leo Batson died testate June 21, 1968, in Apt. 1036, File 13, devising one-half interest to Callie B. Batson, his wife, and the other one-half interest to the Peoples National Bank, as trustee, to pay unto Callie B. Batson for life, and at her death, then to be paid to his (R. Leo) brothers and sisters, and in the event any of his brothers and sisters died, then to pay to their children.
