William T. Hall and Panello R. Hall, their heirs and assigns, forever:

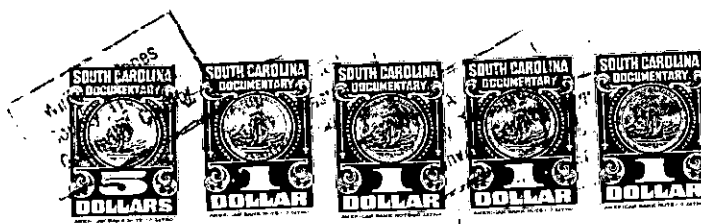
