All those piece, parcels or lots of land in Greenville County, State of South Carolina, on the Old Hundred School Road near the Augusta Road, being shown as Lots One and Eleven on plat of property of J. B. and Ellis King, made April, 1962, by C. O. Riddle, Registered Engineer, and having, according to said plat, the following metes and bounds, to wit:
