A Corporation chartered under the laws of the State of South Carolina and having a principal place of business at Greenville, State of South Carolina, in consideration of

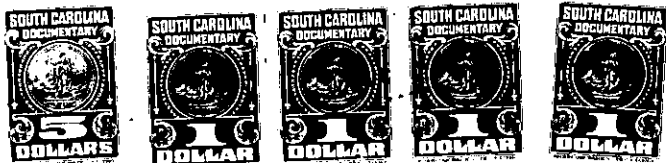

ALL that certain piece, parcel or lot of land, situate, lying and being in the State of South Carolina, County of Greenville, on the corner of Holly Road and Rollingwood Drive, being shown as Lot # 38 on plat of Edwards Forest Heights recorded in Plat Book 000 at Page 89, and being more fully described as follows:

BEGINNING at an iron pin at the joint front corner of Lots 38 and 39 and running thence with the joint line of said lots South 54-38 West 165 feet to an iron pin in the line of lot 48; thence with the line of said lot, South 35-22 East 125 feet to an iron pin on Holly Road; thence along said Road, North 54-38 East 145 feet to an iron pin; thence around the corner, the chord of which is North 9-38 East 28.3 feet to an iron pin on Rollingwood Drive; thence with said Drive, North 35-22 West 103 feet to the beginning corner.
