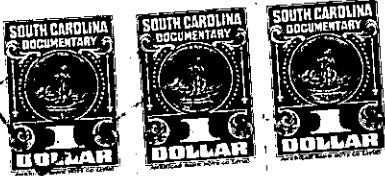
KNOW ALL MEN BY THESE PRESENTS, that I, Judson M. Rice,
