unto STEVE FRANCOSKIAS, his heirs and assigns forever:

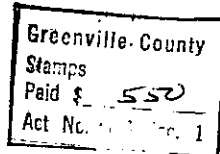

BEGINNING at an iron pin on the northern side of Eastbourne Road, joint corner of Lots 79 and 80 and running thence with the joint line of said lots, N. 33-00 W. 150 feet to an iron pin in the line of Lot 74; thence with the line of Lot 74 and continuing with line of Lot 75, N. 57-00 E. 110 feet to an iron pin, joint rear corner of Lots 78 and 79; thence with the joint line of said lots, S. 33-00 E. 150 feet to an iron pin on the northern side of Eastbourne Road; thence with said road, S. 57-00 W. 110 feet to the beginning corner; being one of the lots conveyed to J.
