release unto CARL J. and GLADYS I. BORDNER, their heirs and assigns forever:

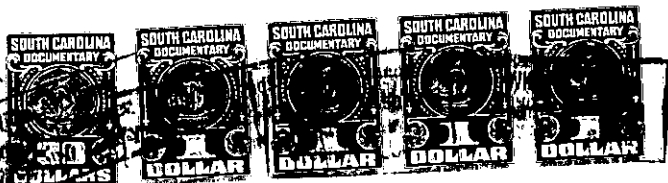
ALL that certain piece, parcel or lot of land, with all improvements thereon,
