his heirs and assigns forever:

All that certain piece, parcel or lot of land situate, lying and being in the  
State of South Carolina, County of Greenville, Bates Township, on the southwestern  
side of Duff Drive, in the town of Marietta, and having, according to a plat prepared  
by J. C. Hill, Surveyor, January 27, 1958, the following metes and bounds, to-wit:
