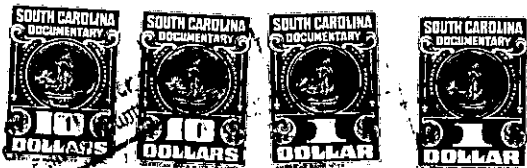
KNOW ALL MEN BY THESE PRESENTS, that Henry L. McKinney -----
