KNOW ALL MEN BY THESE PRESENTS, that we, BESSIE JAMES, C. LEE DILLARD, Executor of the Estate of Eula James Dillard, C. Lee Dillard and NANCY DILLARD TRAVIS

in consideration of -----TEN AND 00/100----- Dollars,
(\$10.00) and in order to settle estate
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

C. LEE DILLARD, his heirs and assigns, an undivided one-half (1/2) interest in that certain piece, parcel or lot of land located in Chick Springs Township, Greenville County, South Carolina, consisting of Lots 11, 12 and 13 on a survey made by W. A. Adams, April 22, 1913, recorded in Plat Book C, page 74, in the R.M.C. Office for Greenville County, having according to said plat the following metes and bounds, to-wit:

BEGINNING at a stake on the edge of the street running to the depot of the P & N Railway 51.9 feet from the edge of the right-of-way of the P & N Railway, and running thence up the said street 155.7 feet to a iron pin at the corner of the said street and James Street; thence turning and running with James Street 166.5 feet to a stake; thence turning and running in a Northerly direction 170.7 feet to a stake; thence turning and running in a Westerly direction 238 feet to the point of BEGINNING.

This is a portion of the same property conveyed to C. F. James by deeds recorded in Volume 71, page 120, and Volume 91, page 216, recorded in the R.M.C. Office for Greenville County, South Carolina.

The grantor, Bessie James, and Eula James Dillard were the sole heirs of C. F. James.

Eula James Dillard died testate on March 25, 1971, leaving as her sole heirs, C. Lee Dillard and Nancy Dillard Travis.
