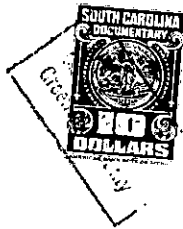
KNOW ALL MEN BY THESE PRESENTS, that We, William T. Satterfield and Ruby T. Satterfield
