KNOW ALL MEN BY THESE PRESENTS, that I, Stanley I. Coleman, of Greenville County,

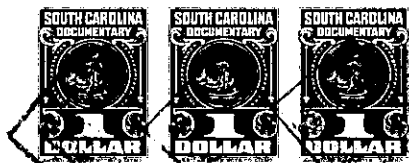
in consideration of Twelve Hundred Fifty and No/100-----(\$ 1250.00)----- Dollars,
