WALLACE M. BALCOME and EDITH B. BALCOME, their heirs and assigns forever:

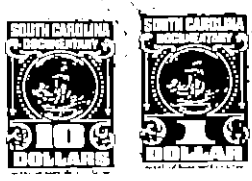
All that piece, parcel or lot of land being known and designated as Lot No.
