The property referred to by this agreement is described as follows: Beginning at ah iron pin in the center of a county road leading off of the Old Buncombe Rd. approximately 245 ft. north thereof and running thence with said road N. 11-20 E., 255 ft. to an iron pin; thence N. 24 E., 162 ft. to a point in said road; thence N. 36 E., 249 ft. to a point in said road; thence along the property of Mollie E. The affidavit of any officer or department manager of Bank showing any part of said indebtedness to remain unpaid shall be and constitute conclusive evidence of the validity, effectiveness and continuing force of this agreement and any person may and is hereby authorized to rely thereon.
