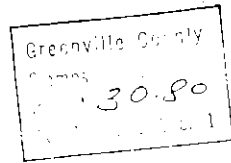
KNOW ALL MEN BY THESE PRESENTS, that William E. Loftis, Jr. and Janice H. Loftis -----
