All that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, being known and designated as Lot No. 8 of a subdivision known as Pine Hill Village as shown on plat prepared by R. K. Campbell, R. L. S., November 30, 1960, and recorded in the R. M. C. Office for Greenville County in Plat Book QQ at Page 168 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern edge of Jacob Road, joint front corner of Lots 7 and 8 and running thence along the joint line of said lots, N. 8-42 E. 146.1 feet to an iron pin at the joint rear corner of Lots 29 and 28; thence along the line of Lot 28, N. 69-17 W. 55 feet to an iron pin at a rear corner of Lot 9; thence along the line of that lot, S. 18-13 W. 135.9 feet to an iron pin on the northern edge of Jacob Road; thence along the northern edge of Jacob Road, S. 63-45 E. 80 feet to the beginning corner;

This conveyance is subject to restrictions and protective covenants recorded in the R. M. C. Office for Greenville County in Deed Vol. 665, at Page 465 and Deed Vol. 703 at Page 351, and is also subject to utilities and drainage easements which appear of record.
