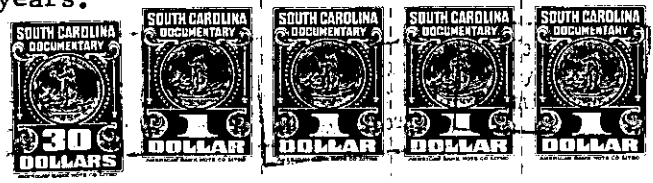
KNOW ALL MEN BY THESE PRESENTS, that HARRY W. OSTEEN
