unto COURTNEY P. HOLLAND, his heirs and assigns;

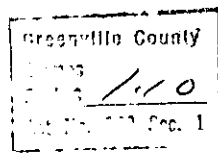

BEGINNING at an iron pin on the southwesterly side of Oak Park Drive, joint front corner Lots 12 and 13, and running thence S. 48-20 W. 151.3 feet to an iron pin; thence S. 40-35 E. 51.6 feet to an iron pin; thence N. 66-22 E. 151 feet to an iron pin on Oak Park Drive; thence along Oak Park Drive, N. 34-02 W. 62.7 feet to an iron pin; thence continuing along Oak Park Drive, N. 41-40 W. 37.3 feet to an iron pin, the point of beginning.

This conveyance is made subject to any restrictions, rights-of-way, or easements that may appear of record on the recorded plat(s) or on the premises.
