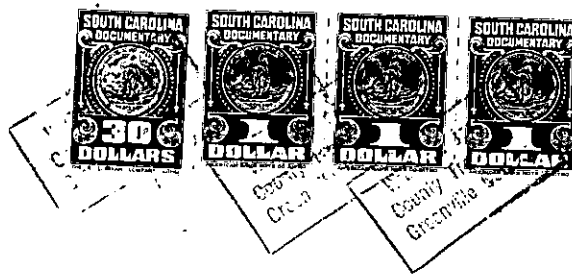
in consideration of Sixteen Thousand Five Hundred and No/100-----(\$16,500.00)-----Dollars,
