ALL that piece, parcel or lot of land in Cleveland Township, Greenville County, State of South Carolina containing 2.09 acres, more or less, and having the following metes and bounds, to-wit:

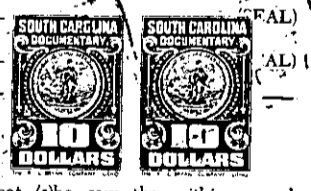
