unto Franklin Enterprises, Inc., its successors and assigns forever:

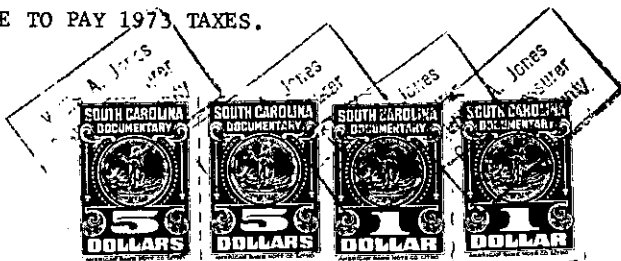

C., in Plat Book 4R, page 6 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwesterly side of East Woodburn Drive, said pin being the joint front corner of Lots 22 and 23 and running thence with the common line of said lots S 59-31 W 207.7 feet to an iron pin, the joint rear corner of Lots 22 and 23; thence S 9-40 E 96.3 feet to an iron pin, the joint rear corner of Lots 23 and 25; thence N 59-31 E 241.9 feet to an iron pin on the southwesterly side of East Woodburn Drive; thence with the southwesterly side of East Woodburn Drive N 30-29 W 90 feet to an iron pin, the point of beginning.
