That if default be made in the performance of any terms becest, or it any of said rental or other sums be not paid to Association when suc, Association, at its election, may declare the entire remaining unpaid principal and interestrof any obligation or indebtedness then remaining unpaid to Association to the due and payable for the ith.

5. That Association may and is hereby authorized and permitted to cause this instrument to be recorded at such time and in such places as Associati tion, In its discretion, may elect.

6. TUpon payment of all indebtedness of the undersigned to Association this agreement shall be and become void and of no effect, and until then It shall apply to and bind the undersigned, their heirs, legatees, devisees, administrators, executors, successors and assigns, and inture northe benefit: of Association and its successors and assigns. The affidevit of any officer or department manager of Association showing any part of said indebtedness to remain unpaid shall be and constitute conclusive evidence of the validity, offectiveness and continuing force of this agreement and any person may. and is hereby puthorized to rely thereon.
