in consideration of FORTY FOUR THOUSAND FIVE HUNDRED and NO/100 (\$44,500.00) - - - - - Dollars,

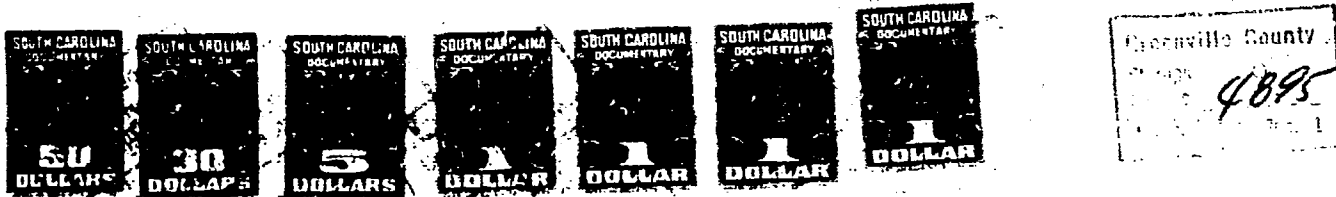
