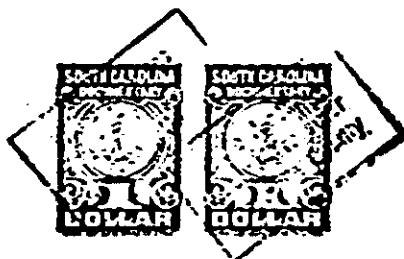
All that piece, parcel or lot of land situate, lying and being on Lockman Drive,
