ALL water lines, mains, valves and appurtenances installed and located in, under or along Old Grove Road, Huntscroft Lane, Mellwyn Street, Mellwood Drive and Emily Lane, County of Greenville, State of South Carolina, including approximately 982 feet more or less of 8 inch pipe, 1 - 8 inch gate valve, 4,970 feet of 6 inch pipe, 10 - 6 inch valves, 4 - 2 inch gate valves, 1,200 feet more or less of 2 inch pipe and 6 fire hydrants, and is shown on a drawing entitled "Prevues Unlimited, Inc. to Commissioners of Public Works of the City of Greenville, S.C.", attached hereto and made a part of this conveyance.
