in consideration of Twenty-Three Thousand Two Hundred Fifty & 00/100 (\$23,250.00) Dollars,

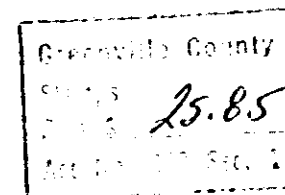
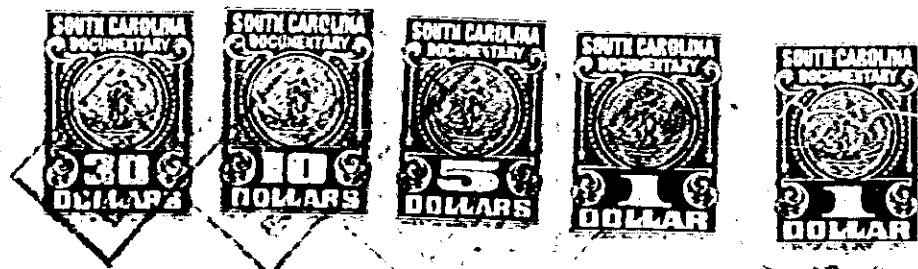
