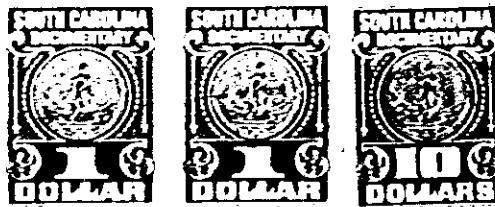
in consideration of FIVE THOUSAND NINE HUNDRED FIFTY (\$5,950.00)----- Dollars,
