release unto BUILDERS & DEVELOPERS, INC., its successors and assigns forever:

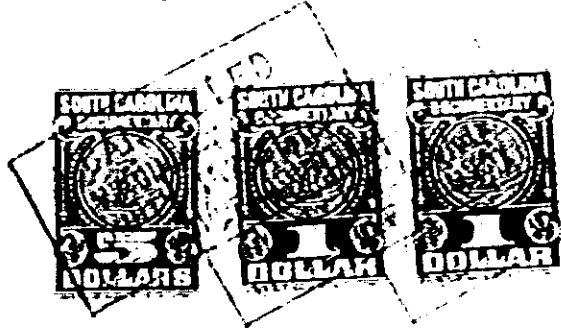
All that certain piece, parcel or lot of land in Greenville County, State of South Carolina,
