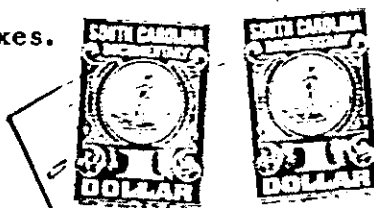
JAMES RAY KING, His Heirs and Assigns:

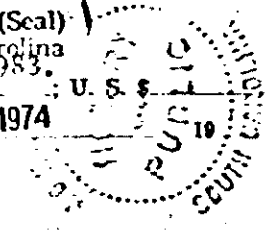
