

DEED

KNOW ALL MEN BY THESE PRESENTS That KATHRYN PYE MORTON, WILLIAM R. PILCHER of the State of Georgia; and HENRY G. PILCHER of the State of Florida, in consideration of the sum of SEVENTEEN THOUSAND FIVE HUNDRED & 00/100 (\$17,500.00) DOLLARS to them in hand paid at and before the sealing of these presents by WILLIAM A. WILLIAMS and wife, SHIRLEY E. WILLIAMS, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant,/sell and release unto the said WILLIAM A. WILLIAMS and wife, SHIRLEY E. WILLIAMS, their heirs and assigns, all that piece, parcel or lot of land in GLASSY MOUNTAIN TOWNSHIP, GREENVILLE COUNTY, STATE OF SOUTH CAROLINA, and described as follows:

All of those pieces, parcels or lots of land, situate, lying and being in Greenville County, State of South Carolina, and in Glassy Mountain Township in the Lake Lanier Development, and being known and designated as Lots No. 1845 and 1846, according to a plat thereof recorded in the R.M.C. Office for Greenville County in Plat Book H, at Page 8, reference to which is hereby made for a complete description of said lots.

The above described property was conveyed to C.A. Pye by deed dated November 25, 1949, duly recorded in the Office for R.M.C. for Greenville County in Deed Book 398, Page 353. Said C.A. Pye died, devising said property by will to his widow, Eva J. Pye, reference Apartment 807, File 4, in the Office of Judge of Probate of Greenville County. Said Eva J. Pye died intestate August 16, 1974 (reference Apartment 1352, File 19 in the Office of Judge of Probate of Greenville County), and the Grantors herein are the heirs at law of said Eva J. Pye.
