the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Jim Williams, Inc., its successors and assigns forever:

BEGINNING at an iron pin on the northwestern side of Canebrake Drive, joint corner of Lots Nos. 11 and 12 and running thence with the joint line of said lots N. 26-44 W. 125 feet to an iron pin at the corner of Lot 14; thence along the line of Lot 14 N. 61-08 E. 93.56 feet to an iron pin at the joint corner of Lots Nos. 12 and 13; thence with the joint line of said lots S. 28-50 E. 144.78 feet to an iron pin on the northwestern side of Canebrake Drive; thence with said Drive S. 72-24 W. 16.59 feet to an iron pin; thence continuing with said Drive S. 72-40 W. 83.42 feet to the BEGINNING corner.

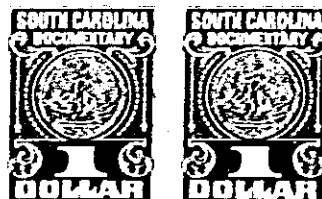
