the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and
release unto William Czyewski, Charlotte Smith, and Mike Winston, as trustees for the Oakview
Community Club, their successors and assigns forever:
