

BEGINNING at an iron pin on the northwestern side of Delta Drive at the joint front corners of Lots Nos. 12 and 13 and running thence along the common line of said lots, N. 58-30 W., 165 feet to an iron pin; thence N. 31-30 E., 165 feet to an iron pin on Vinson Drive; thence along the westerly side of Vinson Drive the following courses and distances: S. 60-15 E., 70 feet to a point, S. 46-15 E., 53.4 feet to a point, S. 32-15 E., 29.1 feet to a point; thence with the curve of the intersection of Vinson Drive with Delta Drive, the chord of which is S. 0-15 E., 34 feet to an iron pin on Delta Drive; thence along the northwestern side of Delta Drive, S. 31-30 W., 116.2 feet to an iron pin, the point of beginning. -308-427-1-19
