BEGINNING at an iron pin at the southeastern corner of the intersection of Kondros Circle and Boling Road and running thence with Boling Road, N. 85-46 E., 85.25 feet to an iron pin; thence S. 2-45 E., 161.5 feet to an iron pin on property now or formerly of Robert Tollison; thence with the Tollison property line, S. 85-45 W., 134.25 feet to an iron pin on the eastern edge of Kondros Circle; thence with the edge of said Kondros Circle, N. 14-00 E., 170 feet to an iron pin, being the point of beginning.
