Office in and for Greenville County. Being the same parcels of land conveyed to Southern Franklin Process Company by C. B. Excluding, however, from the above-described three parcels that certain lot or parcel of land near said City of Greenville in the County of Greenville, conveyed by Southern Franklin Process Company to The Franklin Baptist Church by deed dated November 30, 1955, which parcel of land is bounded and described as follows:

BEGINNING at an iron pin on the Southeastern side of Tremont Street, 108 feet in a Northeasterly direction from the Eastern corner of the intersection of Stafford Street and Tremont Street in the line of property formerly conveyed by Southern Franklin Process Company to The Franklin Baptist Church and running thence with the line of said property S. 30-20 E. 50 feet to an iron pin; thence N. 59-46 E. 27 feet to an iron pin; thence S. 30-20 E. 100 feet to an iron pin; thence N. 59-46 E. 50 feet to an iron pin; thence N. 30-20 W. 150 feet to an iron pin on the southeastern side of Tremont Street; thence with the Southeastern Side of Tremont Street S. 59-46 W. 77 feet to the point of beginning.
