the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Wyman H. McCrary, Jr., his heirs and assigns, forever:

All our right, title, and interest in and to the following described property:

ALL that certain piece, parcel, and tract of land lying and being situated in Paris Mountain Township, County of Greenville, State of South Carolina, containing 29.95 acres, more or less, and being described as the remaining portion of a tract of land in which Maggie Florine Lipscomb was conveyed an interest by G. E. West and others under date of September 16, 1933, by a deed recorded in the Office of the R. M. C. for Greenville County in Book 77, at Page 180.

The said land is made up of two conveyances made to C. S. West, less, however, ten (10) acres, conveyed off to R. R. West under date of September 18, 1933, by a deed recorded in the Office of the R. M. C. for Greenville County in Book 115, at Page 528. One of the tracts of land in question was conveyed to C. S. West by P. D. Roper by deed dated December 7, 1904, and recorded in the Office of the R. M. C. for Greenville County in Book NNN, at Page 452, and covers and conveys 37 and 3 quarters acres conveyed to Claude West by Mrs. F. L. Cunningham, the deed dated February 17, 1906, and recorded in the Office of the R. M. C. for Greenville County in Book WWW, at Page 447. The property conveyed here included all of the two conveyances made unto the said West except the ten acres conveyed away by Maggie Florine Lipscomb unto R. R. West.

LESS, HOWEVER, those certain tracts heretofore conveyed by Maggie Florine Lipscomb to Walter Francis Lipscomb by deed dated February 23, 1955, and recorded in the R. M. C. Office for Greenville County in Deed Book 519 at Page 373; by Maggie Florine Lipscomb to Preston Julius Lipscomb by deed dated February 23, 1955, and recorded in said R. M. C. Office in Deed Book 519 at Page 375; and by deed of Beatrice L. Arnold, Executrix for the Will of Florine Bramlett Lipscomb, to Preston J. Lipscomb dated May 18, 1977, and recorded in said R. M. C. Office in Deed Book 1056 at Page 786; leaving a balance of approximately 24.77 acres conveyed hereby.

It is the intention of the Grantors herein by this deed to convey all the remaining portion of the tract originally conveyed to Maggie Florine Lipscomb by deed of E. Inman, (continued on back)

together with all and singular the rights, members, hereditaments and appurtenances to said premises belonging or in any wise incident or appertaining, to have and to hold all and singular the premises before mentioned unto the grantee(s), and the grantee's(s) heirs or successors and assigns, forever. And, the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) heirs or successors, executors and administrators to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee's(s) heirs or successors and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
