the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto GLENN WAYNE DWIGHT MARTIN, his heirs and assigns forever:

ALL that certain lot of land lying in the County of Greenville, State of South Carolina, and being shown as Lot 57 on a plat of Woodlawn Mills, Simpsonville, South Carolina, recorded in the R.M.C. Office for Greenville County in Plat Book 66, on page 1, and having the following course and distances:

Said lot is composed of the rear 40 feet of Lot 57 as shown on the above mentioned plat. The property is bounded on the Southeast by a 10-foot alley for a distance of 40 feet; on the Northwest by Lot 58 for a distance of 40 feet; on the Northwest by the remaining portion of Lot 57 for a distance of 40 feet; and on the Northwest by Lot 56 for a distance of 40 feet.

Also, Grantor hereby conveys to Grantee a right-of-way over the Southwestern side of the remaining portion of Lot 57. Said right-of-way shall extend from grantor's Northeasternmost corner to "A" Street. It shall be ten (10) feet in width and the Eastern boundary of said right-of-way shall be the joint line of Lots 56 and 57, as shown on the above referred to plat.
