Thomas Wyche, all my right, title and interest in and to a one-eighth (1/8th) interest of, in and to the following described property:

ALL that certain piece, parcel or lot of land with improvements thereon, situate, lying and being on the southern side of East Washington Street, being described according to a plat of property of R. R. Stokes prepared by R. E. Dalton, on October 1949, recorded in Deed Book 450, page 534, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at a point on the southern side of East Washington Street, which point is 25 feet in a northwesterly direction from the Southwestern corner from the intersection of East Washington Street and Irvine Street, and running thence along the Southern side of East Washington Street, N. 70-54 W. 71.35 feet to an iron pin; thence S. 20-32 W. 173 feet to an iron pin; thence S. 70-54 E. 96.6 feet to an iron pin on the western side of Irvine Street; thence along the western side of Irvine Street, N. 20-27 E. 73 feet to an iron pin on the Northern side of a 10-foot alley; thence along the northern side of said 10-foot alley, N. 70-54 W. 25 feet to an iron pin; thence N. 20-27 E. 100 feet to the beginning corner. This conveyance is subject to the right in and to a ten-foot alley created by deed from R. R. Stokes to Belle B. Hunt, recorded in Deed Book 212, Page 59, dated June 29, 1939.

Being the identical property conveyed to grantor and Potter & Shackelford, Inc., by deed dated February 7, 1952, recorded in Deed Book 450, Page 533. On May 1, 1952, grantor herein conveyed to Alfred F. Burgess a one-fourth (1/4th) interest in said property, said deed being recorded in Deed Book 455, Page 538.

Grantor is retaining a one-eighth (1/8th) interest in said property.
