in consideration of the sum of One Dollar, to me (or us) in hand paid, and other valuable consideration at and before seating and delivering thereor, by the City of Greenville, receipt of which is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell, and release, unto the said City of Greenville, its successors and assigns, a right-of-way for the construction of a section of the City Roadway, including necessary drainage ditches and sidewalks from

Shown by plans prepared by the City of Greenville on and over all land which I (or we) own and are further described below, for the purpose of locating, constructing, improving, and maintaining the above described highway with the bridges and causeways thereon, and the right to construct and maintain controlled access facilities to said highway:

Said property is described as follows: ALL that piece parcel or lot of land in the City of Greenville, County & State aforesaid and lying the east side of Spartanburg Street and having the following metes and bounds to wit: BEGINNING at an iron pipe on the Old Spartanburg Road, adjoining property formerly belonging to Love; thence with the line of said property, S. 32-21 E. 168 feet, more or less, to am iron pipe; thence N. 83-00 E. 35 feet, more or less, to a point at the Southeast corner of the boundary line of the property being simultaneously conveyed to Julia Benson; thence along the boundary line of said property N. 32-21 W. 134 feet, more or less, to a point on the Old Spartamburg Poad at the Northeast corner of said property being simultaneously conveyed to Julia Benson; thence along said Old Spartanburg Road, S. 51-45 W. 35 feet, more or less, to the begirning corner. This is the same property conveyed to Julia Benson from Nattie Sue Bowens Knuckles and is recorded in the RMC office in Deed Volume 547 page 339 on March 12, 1956 at 2:33. It is agreed that buildings, fences, signs or other obstructions will not be erected by me (or us), my heirs, assigns or administrators within the limits of the right-of-way herein conveyed and that such buildings and fences as are now within the limits of the right-of-way herein conveyed will be moved from the right-of-way and restored in as good condition as before moving at the expense of the City of Greenville, South Carolina.

TO HAVE AND TO HOLD, all and singular, the said right-of-way and the rights herein before granted, unto the said City of Greenville, its successors and assigns forever.
