All that tract of land in the county of Greenville, state of South Carolina, on the southeast side of Tripp Road, containing 22 acres as shown on plat made by W. R. Williams, Jr. L.S., December 14, 1977 and having according to said plat the following metes and bounds, courses and distances, to-wit:

Beginning at an iron pin in the center of Tripp Road, corner of Mays L.
