County of Greenville, State of South Carolina, described below:

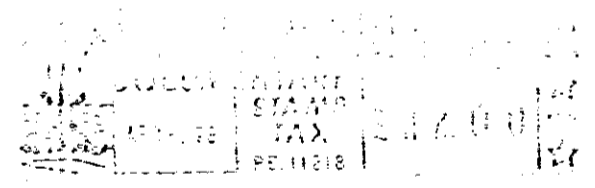
