H. J. Martin and Joe O. Charping, their heirs and assigns, forever:

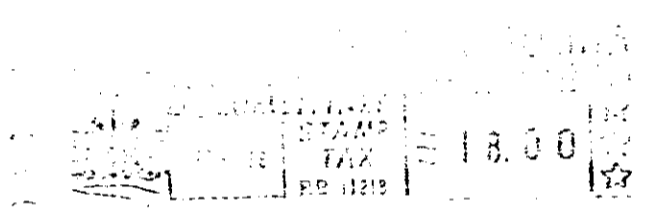
