sell and release unto Richard M. Duncan and Judith A. Duncan

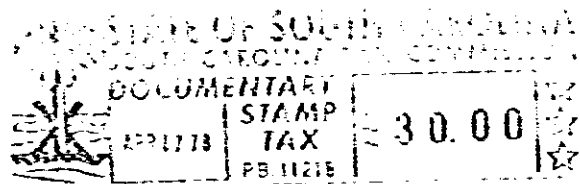
ALL that lot of land situate on the southwestern side of Red Oak Court in the
