ALL that certain piece, parcel or lot of land situate, lying and being on the West side of Holmes Drive in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 95 of White Oak Subdivision, Northside Development Company, and being more particularly shown on plat prepared by John D. Pellett, Jr. in August, 1946, and recorded in the RMC Office for Greenville County in Plat Book P at page 121, and having, according to said plat, the following description:

BEGINNING at a stake on the West side of Holmes Drive, joint corner of Lots Nos. 95 and 94 and running thence with the line of Lot No. 94, S. 84-04 W. 200 feet to a stake on the rear line of Lot No. 83, joint corner of Lots Nos. 94 and 95; thence with the rear line of Lots Nos. 83, 82 and 81, S. 4-56 E. 80 feet to a stake, joint corner of Lots Nos. 95 and 96; thence with the line of Lot No. 96, N. 85-04 E. 200 feet to a stake on the West side of Holmes Drive, joint corner of Lots Nos. 95 and 96; thence with the West side of Holmes Drive, N. 4-56 W. 80 feet to the point of beginning.

This being the same property conveyed to the Grantors by deed of Addie T. Watson dated February 13, 1974 and recorded in the Greenville County RMC Office in Deed Book 993 at Page 798.
