All that piece, parcel or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, at the northwestern corner of the intersection of Dexter Drive with Delrose Circle, being shown and designated as Lot No. 65 on a plat of Drexel Terrace, made by Piedmont Engineering Service, dated April 1, 1961, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book QQ, page 177, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Dexter Drive, at the joint front corner of Lots Nos. 65 and 66, and running thence along said Dexter Drive S. 1-07 W., 80 feet to a point; thence continuing along said Drive, S. 2-48 W., 75 feet to a point at the intersection of Dexter Drive with Delrose Circle; thence with the curve of the intersection of said Drive with said Circle, the chord of which is S. 46-45 W., 32.2 feet to an iron pin; thence along the northern side of Delrose Circle, N. 83-05 W., 120 feet to an iron pin; thence along the line of Lot No. 81, N. 11-23 E., 169.1 feet to an iron pin at the joint rear corner of Lots No. 65 and 81; thence along the line of Lot No. 66, S. 88-06 E., 107.2 feet to an iron pin, the point of beginning.
