in consideration of Six Thousand and No/100 (\$6,000.00) -- Dollars,

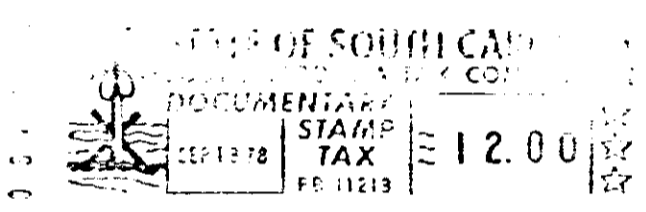
