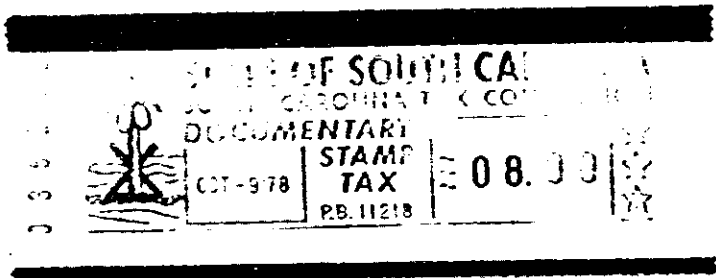
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

All that piece, parcel or tract of land containing 3.38 acres, more or less, situate, lying and being on the eastern side of Holiday Dam Road in the County of Greenville, State of South Carolina, and having, according to a plat prepared by Robert Jordon, R.L.S., dated January 30, 1968, entitled "Property of Curtis W. Coker", recorded in the R.M.C. Office for Greenville County in Plat Book YYY, Page 135, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Holiday Dam Road at the joint corner of the premises herein conveyed and property now or formerly of Fred Chapman, and running thence with the line of the said Chapman property N. 58-06 E., 394.3 feet to an iron pin; thence with the line of other property of Mattie Kay, S. 16-06 E., 434.5 feet to an iron pin; thence continuing with the line of other property of Mattie Kay S. 73-34 W., 395 feet to an iron pin on the eastern side of Holiday Dam Road; thence with the eastern side of Holiday Dam Road N. 1-21 W., 329.7 feet to the point of beginning.
