

(the receipt whereof is hereby acknowledged), have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto the said william B. Whitehead and Jeanette E. Whitehead and their heirs and assigns forever:

All that lot of land on the north side of Palmer Street, near the Town of Greer, Greenville County, South Carolina, being shown as Lot No. 28 on Plat of Norwood Subdivision of the Holtzclaw property made by W. E. Willis, Jr. January 19, 1916, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the north side of Palmer Street at the joint corner of Lots Nos. 27 and 28 and runs thence along the line of Lot No. 27 N. 20-31 E. 142.5 feet to an iron pin; thence N. 73-04 W. 60 feet to an iron pin; thence along the line of Lot No. 20 S. 20-31 W. 133 feet more or less to an iron pin on the north side of Palmer Street; thence along the north side of Palmer Street S. 60-29 E. 60 feet to the beginning corner.

N. Willis, January 19, 1916.
