release unto Blanche C. Carr, her heirs and assigns forever;

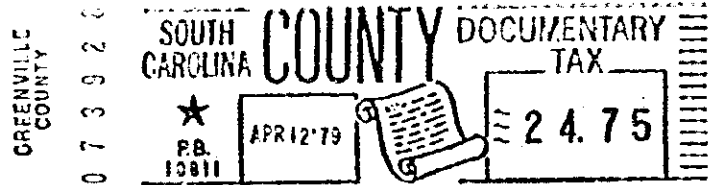
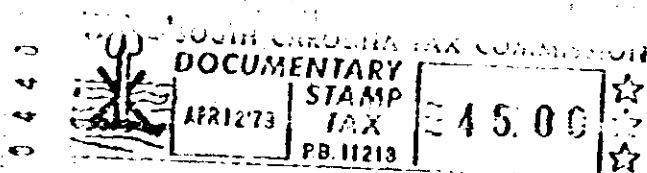
ALL that certain piece, parcel or unit, situate, lying and being in the State of South
