release unto Viola Keeter Wharton and E. M. Horton, Jr., their heirs and assigns forever:

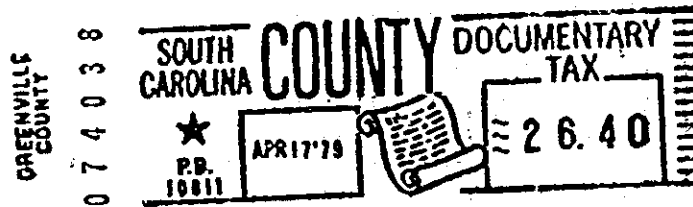
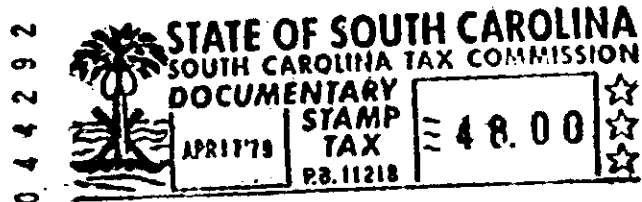
